D. Resolution 2020-R02-05 A Resolution Authorizing the Purchase of a Generator from Oakley Services, Inc. Commissioner Genesio discussed generators that are non-repairable. One was moved to Grant Way lift station and it was never in full operation. This will replace it at \$7,361.00, and parts are readily available. He stated that it is in the budget to replace the generator. Another purchase may be forthcoming. Commissioner Ward asked if it this one was used. Genesio stated it is used but in good condition and easier to get replacement parts if needed. The old one has an engine that does not have parts available. A new generator would cost approximately \$60,000. This generator saves the City funds and is warranted for a period. After the vote, Mayor asked Dave Durkota about the fire house generator. He stated that it is inadequate but doing the job for now. A replacement may be necessary in a few years.

E. Resolution 2020-R02-06 A Resolution Authorizing a Redevelopment Agreement between the City of Du Quoin and the Du Quoin Community Development Corporation (DCDC) to Acquire Property at 226 S. Hickory Street (Public Display) - Aaron Atkins stated that the Resolution should be tabled due to the incorrect classification of a 'Resolution'. The correct classification is 'Ordinance' and it will be corrected for the next council meeting.

Other Business:

Aaron Atkins discussed aspects regarding recreational marijuana. Aaron discussed process required to pass an ordinance regarding marijuana sales. The City's codifier, Frank Heiligenstein, provided a document on guidance for establishing cannabis protocols. It outlines the process and indicates that the Zoning Commission must Zone the locations before an ordinance can be passed by the Council. Mr. Atkins also asked the Council to consider creating ordinances regarding underage possession, underage consumption, and public consumption. Currently, violations are written as State violations and the County benefits from the revenue even though City officers are dealing with the incidents. Having City ordinances will generate revenue for Du Quoin.

Mayor asked what the Council thought regarding referring the issue to the Zoning Commission. Commissioner Ward wants to wait until after March 23. Aaron Atkins mentioned that the people should have the location in order to make an informed decision in November.

Commissioners then discussed whether to have an open session in March if it's going to be on the ballot in November. Commissioner Kirkpatrick suggested just placing it on the ballot. Genesio stated it's a business decision and why do we need to bring it to the people. Mayor indicating taking it to the people was the right thing to do to judge actual public opinion since it is a presidential election year and the turnout is usually far greater than other elections.

Atkins said it is very early in the year and there may be other communities that add it to their ballots in November, but as of now he is not aware of any other communities coordinating such referendums. The law only became effective January. Commissioner Kirkpatrick asked Aaron to get a list of what other communities are doing. Atkins agreed and said he will also prepare the ordinance for the meeting on the $23^{\rm rd}$.

Ward – Echoed sentiments to the Chief and expressed his appreciation for all that he and Dave Durkota and their staff do for the City.
