Treasurer's Report for the period November 1 through November 30, 2019: Treasurer Stephanie Cravens said that the Governmental Funds had revenues of \$566,262 versus \$403,340 in expenses for a positive change in fund balance of \$162,921. However, she said that there was a Fire and Police Pension Fund payable of \$196,051 so the change was actually negative \$33,130. On the business side, she said that the Water Funds had revenues of \$207,533 and expenses of \$158,051 for a positive change in fund balance of \$49,482. Lastly, she said that total cash for all City funds less accounts payable and payroll increased by 11% or \$259,113 from \$2.35 million on a year over year basis. The Council approved the Treasurer's Report for November, 2019.
