Minutes of the June 11, 2018 Meeting

Minutes:

The Minutes of the City Council of the City of Du Quoin, County of Perry, held on this 11th day of June in the year 2018, said meeting held in the Council Chambers of the Du Quoin City Hall.

Invocation:

Reverend Lon McPherson of Liberty Church gave the invocation.

Call to Order:

Mayor Alongi called the meeting to order at 6 p.m. with the following individuals present: Commissioners Michael Ward, Jill Kirkpatrick, and Charles Genesio. City staff included City Attorney Aaron Atkins, City Treasurer Stephanie Cravens, and City Clerk Andrew Croessman.

Previous Meeting Minutes:

The Council reviewed the May 29th regular meeting minutes. Commissioner Ward moved, Commissioner Kirkpatrick seconded a motion to approve the regular meeting minutes. Motion passed; all ayes.

Treasurer's Report:

Treasurer's Report for the period January 1 through April 30, 2018: City Treasurer Stephanie Cravens said that the Governmental Funds had revenues of \$1.55 million versus \$1.54 million in expenses, and cash increased from \$489,660 to \$669,726. On the business side, she said that the Water Funds had revenues of \$1.1 million and expenses of \$896,000, and cash increased from \$87,873 to \$301,800. Lastly, she said that total cash for all City funds increased \$204,489 from \$1.89 million to \$2.1 million. Commissioner Kirkpatrick moved, Commissioner Genesio seconded a motion to approve the Treasurer's Report. Motion passed; all ayes.

Approval of Bills:

Commissioner Ward moved, Commissioner Kirkpatrick seconded a motion to approve the bill list for June 11, 2018. Motion passed; all ayes.

Appointments:

Commissioner Genesio moved, Commissioner Ward seconded a motion to reappoint Mr. Ted Harsha to the Police Pension Board. Motion passed; all ayes.

Resolutions:

City Clerk Andrew Croessman said that the next two Resolutions were to correct the record for Motor Fuel Tax (MFT) projects completed in 2013 and 2015. These inconsistencies were found during a recent MFT audit for the period 2013 through 2017. He said that the City would not have to reimburse the MFT Fund for these inconsistencies as they were allowable expenses.

A. 2018-R06-01: A Resolution Authorizing the Use of Motor Fuel Tax Funds in the Amount of \$4,816.61 to Resurface Route 51 Parking Lanes in 2015. Commissioner Ward moved, Commissioner Genesio seconded a motion that 2018-R06-01 be approved. Motion passed; all ayes.

B. 2018-R06-02: A Resolution Authorizing the Use of Motor Fuel Tax Funds in the Amount of \$5,630.38 to Widen and Resurface Sunset Avenue in 2013. Commissioner Genesio moved, Commissioner Kirkpatrick seconded a motion that 2018-R06-02 be approved. Motion passed; all ayes.

Commissioners' Comments:

Mayor Alongi said that the City is aware and is finding a resolution to Midwest Inn pumping water into Wells Street. Second, he encouraged all to come out to the dedication of John Croessman Square on Thursday at 7 p.m.

The City Council adjourned at 6:16 p.m., motion by Commissioner Genesio, seconded by Commissioner Kirkpatrick; all ayes.
