C. 2019-O05-02: An Ordinance Authorizing the Execution of a Professional Service/Consultant Agreement with Economic Developer Jeffrey Ashauer. The consultant agreement is for four years with annual fees of \$32,400, \$33,540, \$34,704, and \$35,928 in years one through four, respectively. Resolutions:

A. 2019-R05-01: A Resolution Authorizing a Redevelopment Agreement between the City of Du Quoin and Matthew Jackson on behalf of the Redevelopment of 210 East Main Street. Mr. Ashauer said that this agreement provides reimbursements of \$16,000 on \$47,000 of construction costs at the old Moore's Scrapbooking building. Commissioner Karnes moved, Commissioner Genesio seconded a motion that 2019-R05-01 be approved. Motion passed; all ayes.

B. 2019-R05-02: A Resolution Authorizing the Purchase of an Aerator Assembly for the Water Reclamation Plant. Commissioner Genesio moved, Commissioner Kirkpatrick seconded a motion that 2019-R05-02 be approved. Motion passed; all ayes.

C. 2019-R05-03: A Resolution Authorizing Condemnation of 515 North Vine Street. Commissioner Genesio moved, Commissioner Karnes seconded a motion that 2019-R05-03 be approved. Motion passed; all ayes.

D. 2019-R05-04: A Resolution Authorizing Condemnation of 526 West Park Street. Commissioner Ward moved, Commissioner Karnes seconded a motion that 2019-R05-04 be approved. Motion passed; all ayes.
