Other Business:

Mayor Alongi discussed the tax revenues for the City of Du Quoin year ending 2020. In summation, the City is behind approximately \$213,000 from 2019 in the categories not restricted, Municipal and Home Rule sales tax and Local Use (online) sales tax. And there are indicators that the first few months in 2021 will fall short of 2020 and 2019's totals. There is also a possibility that the Income tax in 2021 will be below 2020 as many were laid off due to the pandemic.

Commissioners' Comments:

Genesio – Wished all a Merry Christmas. Prayers for Josh Gross's father and all those sick with Covid. Hope everyone does their best to keep their families safe. There are things that you have to do like going to work. Wished everyone a speedy recovery. Addressed the property tax increase, was emphatic that none of the commissioners want to put the burden on the citizens. Asked everyone to bombard the State Legislatures with requests to fix the issue. The folks in Springfield can fix it if there is support to do it. Everyone downstate municipality needs to petition the legislature to find a fix and possible move the downstate pensions into IMRF. Our first responders need to know they have security with their pensions. He said God Bless everyone and wished everyone a Merry Christmas.

Ward – Wished a Merry Christmas and Happy New Year to everyone. He stated he never thought the pandemic would hit this close to home. Asked for prayers for the vaccine and cure. He said it shows what the community thinks of our 1st responders as they did not complain about the tax increase. He was insistent that we have to keep going to find solutions to fund the pension and not put the burden on our taxpayers. To Aaron Akins, he was glad he was o.k. after his accident over the weekend. He knew that Aaron was a Christian man that he was thanking God for protecting him. He said he appreciated what everyone does and let's continue to work together.

Kirkpatrick – Echoed what was said previously. She was glad Aaron was alright and asked for prayers for David Gross and his family. She offered condolences for Dave Eaton's family. Wished everyone a Merry Christmas.

Karnes – Told Aaron Atkins that he was glad he was o.k, mentioned prayers for David Gross and condolences for the Eaton's. He wanted to mentioned that the Teachers Retirement fund in Illinois had not been fully funded since 1956. And the State needs to fix the pension issues. He then wished everyone a Merry Christmas and reminded them to remember the true meaning of Christmas. Stay safe

and concerned about others. He gave congratulations to Eric Kirkpatrick on being name Coach of the Year for his work with the girls cross-country and track teams. He also praised Cody Doerflein on his accomplishments, his is a good story that was published in the Southern Illinoisan. Coach Karnes also wanted it known that there was an article in the Southern about him that neglected to give his wife the credit she deserves. Pat Karnes has always been there supporting him and the families and kids of Du Quoin.

Hale – Thanked everyone for a difficult first year as City Clerk. Reminded everyone that there is a lot to be thankful for and during this season to take time to remember those blessings. Wished everyone a Merry Christmas and Happy New Year.

Mayor – Responded to Commissioner Genesio and said that some morning he wakes up mad. Said we all have had to deal with things we have never dealt with before. We cannot fix these things. Especially pensions. It is bigger than us. All downstate municipalities need to come together to propose a solution. He thanked the tourism girls for the lights fair. Attendance at the Fairgrounds has been great. Last weekend saw almost 600 children to visit Santa. He wished everyone a Merry Christmas. Said the pandemic has not been easy. Sometimes text messages take emotions out of it and we misunderstand others. We have all had times when we have not gotten along but we need to remember what we were elected to do and that is represent the citizens of Du Quoin. We must embrace and respect each other. Agree to disagree. We will see each other on the 28th and hope that all have a Merry Christmas and that 2021 is a more prosperous year. The State of Illinois announced a lineup for the 2021 State Fair so that shows they are in support of our community. They understand what an economic driver the Fair is so that is good news. Thoughts and prayers to Josh Gross and his father. Pray for everyone to get through the holidays.
