# **Treasurer's Report:**

City Clerk Ruth Hale presented the Treasurer's Report for the month ending February 28, 2021. She reported the following:

- Governmental Funds had negative earnings of \$81,476 to date in 2021
- Proprietary Funds had a positive change of \$51,403 to date in 2021
- Tax Revenues are up \$84,584 compared to the end of February 2021

The Mayor then addressed the council regarding tax revenues. He explained the Consumer Price Index (CPI) and its effect on the economy in relation to inflation rates. Factoring in CPI data from the last two years, he concluded that the City will still be behind target on 2021 revenues versus expenditures even at the current pace. The City will remain cautious in regard to the financial picture as the impact of the global pandemic on the rest of 2021 remains unpredictable.
