Public Comment:

EMA Coordinator Doug Clark congratulated the Fire Department on their grant. He then announced that his department had received their annual grant that will cover over 40% of the budget. They have received the grant for over 20 years and it helps cover the expenses. The funding provides them ability to offer assistance after severe weather emergencies such as the recent tornadoes. The Mayor then asked about a siren system in the Du Quoin Fairgrounds. Doug mentioned that the state would have to be willing to work with us. The Mayor also inquired about cost. Commissioner Genesio quoted a 1994 price and said he couldn't answer to current cost. The Mayor is concerned because of all the large events in the fairgrounds and the need for notifications. He also indicated a warning system inside the event center possibly tied to the lighting of the building. He then asked Doug to reach out to the Fairgrounds Director, Josh Gross, about coordinating an effort to install sirens.
